



# PCORI/CERF FEES

PPACA – Patient Protection and Affordable Care Act

## PCORI / CERF Fee Periods and Payment Schedule

- The fee per average covered life *changes* on October 2nd of each year.
- The fee *is payable* on July 31 of the calendar year following the plan year-end date.

PPACA Section 1181 established PCORI as an independent, non-profit organization to evaluate and compare health outcomes and clinical effectiveness, risks, and benefits of medical treatments, services, procedures, drugs or other strategies that treat, diagnose or prevent illness or injury.

- CERF = Comparative Effectiveness Research Fee.
- PCORI = Patient-Centered Outcomes Research Institute, what was created by PPACA to do the research.
- PCORT = Patient-Centered Outcomes Research Trust fund – same concept, just the fund of collected monies for this purpose/study.
- For CERF payments, ERISA plan year is key. If your ERISA plan year and renewal date are different, use the ERISA plan year to calculate your fee per covered life and payment due date.
